From Global Washington's Executive Director

Dear Global Washington supporters, members, and friends:

This last year was one of urgent reflection and a renewal of our commitment to make the world a better place for everyone. We continue to believe in Washington as a global state, and as Richard Stearns, the outgoing president of World Vision U.S., has said, "We have the chance to remind people in their worst moments what's best about us as a nation. We can show our greatness by setting an example for the rest of the world in our compassion and respect for human rights."

The 2017 Global Washington annual conference brought together over 400 members of the global development community to explore the theme of "Renewing Global Leadership." We also celebrated our very own Northwest leaders who are global leaders, including UW President Ana Mari Cauce and Starbucks' head of Global Public Affairs and Social Impact, John Kelly.

While the conference is the event for which we're perhaps best known, Global Washington also hosted a number of more timely and intimate events for our members and supporters throughout the year. Our intention, as always, is to strengthen our member's skillsets, grow their networks in impactful ways, and improve their access to resources and influence.

We held 19 events during the year, including a roundtable with the president and CEO of the Atlantic Council; an evening at the Bill & Melinda Gates Foundation with Professor Muhammad Yunus; and an event in celebration of International Women's Day.

In addition, we partnered with Seattle's World Affairs Council and JPMorgan Chase on a panel event about how innovative financing mechanisms are improving sustainability and increasing incomes for small-holder farmers globally. And we hosted a sold-out panel discussion, jointly organized with the Washington Global Health Alliance, on the unique challenges that women face in pursuing careers in global health and development.

As a baseline for future goal-setting, in 2017 we produced a report called *Assessing the Global State*, to review the economic impact and interconnectedness of our members across the board. What we found is that the economic impact of the global development sector here in Washington state is both sizeable and growing. When we celebrate our ten year anniversary at the end of 2018, we will be announcing an initiative that will tap into the vast network of our global development community to do some truly extraordinary work together. 
